

INSTRUCTIONS

(for Petition to Prohibit the Sale of Alcoholic Liquor After 2:00 A.M.)

The following instructions must be strictly followed to produce valid signatures:

IF YOU ARE A PERSON SIGNING THE PETITION (SINGLE SIGNATURE ON PETITION):

1. You must be 18 or older.
2. You must be a citizen of the United States.
3. You must be a resident of the City of Peoria.
4. You must be a registered and qualified voter of the City of Peoria.
5. You must have your signature notarized unless there is a circulator who notarizes all the signatures on the Petition (see below).

Note: You must use your signature as it appears on your Voter's Registration Card.

IF YOU ARE THE CIRCULATOR OF THE PETITION (MULTIPLE SIGNATURES ON PETITION):

1. You must be 18 or older.
2. You must be a citizen of the United States.
3. You must witness each of the signatures on the Petition.
4. You must be able to affirm, to the best of your knowledge and belief, that the persons signing the Petition are duly registered and qualified voters residing in the City of Peoria, and that their addresses are correctly stated on the Petition.
5. You must have your signature (only your signature) notarized at the bottom of each Petition. Otherwise all signatures on the Petition are invalid.
